On 29-Jan-2019, a call was made to 911 and when police arrived, Jussie SMOLLETT stated he was the victim of an Aggravated Battery stating that two individuals beat him, poured an unknown substance on him, and placed a rope around his neck at the location of 341 E. Lower North Water Street, Chicago, Cook County IL. On 13-Feb-2019, Police located and interviewed [redacted] and [redacted] who both stated SMOLLETT planned and staged the attack with the cooperation of [redacted] and [redacted]. Statements made by [redacted] and [redacted] were memorialized on videotape. Through investigation it was determined that the incident, as related by SMOLLETT, did not occur. At 0510 hours on 21-Feb-2019, SMOLLETT was read his MIRANDA warnings with Attorney [redacted] present and declined to answer questions.
