#### COUNT 1

BRIANNA SHONTAE WILLIAMS on or between April 17, 2019 and November 6, 2019, in the County of Duval and the State of Florida, did willfully torture, maliciously punish, or willfully and unlawfully cage and a person under the age of 18 years, contrary to the provisions of Section 827.03(1)(a), Florida Statutes.

#### **COUNT 2**

BRIANNA SHONTAE WILLIAMS on or between April 17, 2019 and November 6, 2019, in the County of Duval and the State of Florida, did willfully or by culpable negligence neglect by being the child's caregiver and failing to provide with the care, supervision, and services necessary to maintain the child's physical and mental health, including but not limited to, food, nutrition, clothing, shelter, supervision, medicine and medical services that a prudent person would consider essential for the well-being of the child, and in doing so did not cause great bodily harm, permanent disability or permanent disfigurement to , age five, contrary to the provisions of Sections 827.03(1)(e) and 827.03(2)(d), Florida Statutes.

#### **COUNT 3**

BRIANNA SHONTAE WILLIAMS on or between April 17 2019 and November 6, 2019, in the County of Duval and the State of Florida, did willfully or by culpable negligence neglect by being the child's caregiver and failing to provide with the care, supervision, and services necessary to maintain the child's physical and mental health, including but not limited to, food, nutrition, clothing, shelter, supervision, medicine and medical services that a prudent person would consider essential for the well-being of the child, and in doing so did not cause great bodily harm, permanent disability or permanent disfigurement to age five, contrary to the provisions of Sections 827.03(1)(e) and 827.03(2)(d), Florida Statutes.

#### **COUNT 4**

BRIANNA SHONTAE WILLIAMS on or between April 17, 2019 and November 6, 2019, in the County of Duval and the State of Florida, did knowingly and willfully gives false information to a law enforcement officer who is conducting a missing person investigation involving a child 16 years of age or younger with intent to mislead the officer or impede the investigation. and the child who is the subject of the investigation suffers great bodily harm, permanent disability, permanent disfigurement, or death, contrary to the provisions of Section 837.055(2), Florida Statutes.



## **COUNT 5**

BRIANNA SHONTAE WILLIAMS on or between April 17, 2019 and November 6, 2019, in the County of Duval and the State of Florida, knowing that a criminal trial, proceeding or investigation by a duly constituted prosecuting authority, law enforcement agency or grand jury of this state, was pending or about to be instituted, did, alter, destroy, conceal or remove any record, document or thing, to-wit: transport human remains, with the purpose to impair its verity or availability in such proceeding or investigation, contrary to the provisions of Section 918.13(1)(a), Florida Statutes.
